What is Express Cash?

Express Cash from American Express® is a service which enables you to obtain cash easily from Automated Teller Machines (ATMs) when you go on business trips. It's just what you need to handle small cash expenses.

Where can I use the Express Cash service?

- Wherever you are in the world, you have access to Express Cash 24 hours a day, 7 days a week.
- Express Cash is available at over 1,000,000 ATMs worldwide. Please visit www.amexnetwork.com/atmfinder to select a specific region and view the ATMs available there.

How does it work?

- Activate the Express Cash service by completing the details below.
- To use the Express Cash service insert your Card into the ATM, type in the PIN, then the amount you wish to withdraw. The ATM will dispense the cash immediately.
- You may withdraw up to US\$/€500 in local currency during a 14 day period (US\$/€1,000 every seven days with the International Currency Gold Corporate Card).
- Each Express Cash withdrawal you make appears with your other Charges on your monthly Corporate Card statement. Every time you use the service you will be charged a fee. The fee is 4% of the value withdrawn with a minimum charge of US\$/€10.

How can I apply?

- All you have to do is fill out this Activation Form, ensure it is approved by your company's nominated Programme Administrator, and have it sent via email to: iccpaservicinginbox@aexp.com. Please be aware that the Internet and some email services may not always be secure.
- If you are applying for a new Corporate Card, the Express Cash service will be active when you receive your Card. The PIN you will receive will apply to both cash withdrawals and other Charges made on your Card.
- For existing Cardmembers, please allow up to 7 days from the date the form is received for the Express Cash service to be made available. You will not receive a different PIN for the Express Cash service. You can withdraw cash using the same PIN as you would for your regular Card Charges. If you forget your PIN you can view it via your Online Account (americanexpress.com).
- There is no charge for activating the Express Cash service.
