



The Platinum Card® Welcome Offer Terms and Conditions

1. The Welcome Offer (as mentioned in clause 3 of the Terms and Conditions) is only valid for Selected American Express Cardmembers (a) who submit an application for The Platinum Card (Basic Card) applications that are received by American Express International, Inc. ("American Express") in Hong Kong ("**Basic Card**") through the designated links or channels provided by Tesla Motors HK Limited ("**Tesla Motors**") in its promotional mailing, email, online channels or hotline, during the period from October 16, 2024 to December 31, 2024 ("**Promotion Period**") together with all the required valid documents within seven (7) working days from the date of application submission; and (b) have been approved for, received, and activated the Basic Card ("**Eligible Cardmembers**").

3. **Welcome Offer:**
Eligible Cardmembers are entitled to enjoy the following Welcome Offer upon the Basic Card approval of their Eligible Basic Card applications:
 - (a) **Welcome Offer 1:** Eligible Cardmembers are entitled to receive HK\$800 statement credit upon completing an eligible transaction using the Basic or Supplementary Platinum Card issued by American Express in Hong Kong ("**Eligible Card**") within the first month from such Basic Card's application approval date. Statement credit will be credited to the Basic Cardmember's Membership Rewards® Program Account within eight (8) weeks from the completion of the eligible transaction.
