3. To enable alerts log into your account via the Amex App and select "Account" and then "Notifications" to select the alerts that suit you best.
4. Available to clients who use American Express and Concur Expenselt. Enrolment required. Please contact your Program Administrator for more information and access.
5. To manage controls within Amex Mobile App, login to your Amex Mobile App, click on "Account", select "Transaction Security Settings" then enable or disable transactions or set limits as per your requirement. To manage controls within your Online Account, login to your Online Card Account, click on "Account Management", select "Transaction Security Settings" then enable or disable transactions or set limits as per your requirement.
6. For existing Cardmembers, international ATM transactions may be enabled basis their international usage in the past and subject to Corporate level ATM enrolment.
  - a) At the time of issue / re-issue, all cards (physical and virtual) shall be enabled for use only at contact based points of usage [viz. ATMs and Point of Sale (PoS) devices] within India. Issuers shall provide cardholders a facility for enabling card not present (domestic and international) transactions, card present (international) transactions and contactless transactions, as per the process.
  - b) For existing cards, issuers may take a decision, based on their risk perception, whether to disable the card not present (domestic and international) transactions, card present (international) transactions and contactless transaction rights. Existing cards which have never been used for online (card not present) / international / contactless transactions shall be mandatorily disabled for this purpose. Please ensure adherence to the above provided regulatory guidance.
