- 3. American Express is neither responsible nor guarantees the quality of the goods/services nor is it liable for any defect or deficiency of goods or services so obtained/availed by Cardmember at the establishment.
- 4. American Express/Jet Privilege reserves the right to change/withdraw the Terms and Conditions of any offer at any time without prior notice.
- 5. The Benefits/Offers hereunder can be availed only with the Card and cannot be combined with any other promotion or offer.

Important

Effective 14th November 2019, JetPrivilege Program has been renamed as the InterMiles Program. Given this change, the existing JPMiles on your Card will now be called InterMiles. Moving forward, you will earn InterMiles at the usual earn rate on your Jet Airways American Express® Platinum Credit Card.

Please note, Card benefits associated specifically with Jet Airways like complimentary air tickets, accelerated reward earnings, 5% online discount and redemption tickets at jetairways.com, dedicated check-in and excess baggage allowance will not be available as the

airline is currently not operational. However, all other benefits on your Card remain available for you to enjoy, such as complimentary access to eligible airport lounges, iPrefer Elite Tier membership, 24x7 Platinum Concierge Service.

Annual Fees

- 1. Annual Fee will be charged in first month's Card statement upon approval of your Card and after completion of every 12 months thereon.
- 2. Intermiles Platinum tier members will not be charged with Annual Fees till they maintain their Jet Privilege Platinum tier membership.

Welcome Gift – 10,000 Bonus Intermiles

- 1. Welcome Gift of 10,000 Bonus Intermiles will be made available only to Basic Cardmembers who pay the Annual Fee.
- 2. Basic Cardmembers will qualify for the Welcome Gift after the first spend transaction is undertaken on the Basic/Supplementary Card.
- 3. These Bonus Intermiles will be credited to Basic Cardmember's JetPrivilege Account within a period of 60 working days post the first spend transaction as above.
