

OFFICIAL RULES
Harry Styles Ticket Giveaway

NO PURCHASE NECESSARY TO ENTER OR WIN.
MUST BE PRESENT TO WIN.

ELIGIBILITY: The Harry Styles Ticket Giveaway (“Giveaway”) is open to legal U.S. residents, who are 18 or older. Void where prohibited. Employees, officers and directors and their immediate family members (parent, child, spouse or sibling and their respective spouses, regardless of where they reside and those living in their same households, whether or not related) of American Express Travel Related Services Company, Inc. (“Sponsor”), Harry Styles, anyone professionally associated with Harry Styles, and their respective parents, affiliates, subsidiaries and advertising and promotion agencies are not eligible to enter or win. Individuals who are employed by any local, state or federal government office or agency, elected officials and individuals listed on the OFAC Specially Designated Nationals and Blocked Persons (SDN) List are not eligible. By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which are binding and final on matters relating to this Giveaway. Giveaway is subject to all applicable federal, state and local laws.

TO ENTER: Between 12:00 p.m. Pacific Time (“PT”) and 2:00 p.m. PT on December 11, 2019 (“Giveaway Period”), visit the designated location in the Los Angeles, California area (“Event”) and receive a wristband with a unique number, while supplies last. Entrance will be on a first come, first served basis. Sponsor does not guarantee that everyone who wishes to obtain a wristband will be able to do so.

Limit one (1) wristband per person. Wristbands that are sold, auctioned or bartered may be voided at Sponsor’s sole discretion. Wristbands are void if not obtained from authorized and legitimate channels, or if the wristband is, in whole or in part, damaged, irregular, altered, counterfeit, produced in error or obtained via fraud or theft.

Entrants to the Event understand that the Event may be filmed, photographed and/or otherwise recorded by Sponsor (“Event Footage”). Entrants understand that Sponsor shall own all right, title and interest in the Event Footage and that Sponsor and its affiliates, designees, successors and assigns will have the unlimited right to use the Event Footage (including, without limitation, their names, voices, performances and images as embodied therein), edited or altered as Sponsor sees fit, and any material based thereon or derived therefrom, together with any other material, in any manner, and in any and all media whether now known or hereafter devised, anywhere in the world, in perpetuity, for any lawful purposes, including, without limitation, for purposes of advertising or trade without prior notice to, or approval or inspection by, entrants. Sponsor is under no obligation to make use of the rights granted herein.

DRAWING: Potential winners will be selected in a random drawing at or around approximately 2:15 p.m. PT during the Event from all eligible entries received. Odds of winning depend on the number of eligible entries received. The winning numbers will be announced during the drawing and potential winners with those winning numbered wristbands must be present to win. If a potential winner is not present, cannot show his/her wristband with the winning number or is not in compliance with these rules, prize will be forfeited and, at Sponsor’s discretion, an alternate winner selected, time permitting.

PRIZES (650): Two (2) tickets to the Harry Styles concert scheduled to take place at The Forum on December 13, 2019. Approximate Retail Value (“ARV”): \$50 per pair. Total ARV of all prizes:

\$32,500. Winners will be provided with a voucher on which their names will be handwritten. Winners must present the original voucher with a valid photo I.D. in-person to the Will Call window at The Forum on the day of the concert. No other individuals are eligible to receive the tickets and the tickets will not be provided to any individual other than the individual whose name and valid photo I.D. match the name handwritten on the original voucher. Data collected at time of winner verification will only be used for the purpose of fulfilling the prize and for no other purpose. Travel to/from concert is not provided as part of prize and is the sole responsibility of the winners. Tickets will be forfeited if not claimed at Will Call by 7:30PM on Friday, December 13, 2019. Tickets are subject to terms and conditions specified thereon. Only original vouchers will be accepted; no photos of vouchers or mechanical reproductions. Tickets or vouchers that are sold, auctioned or bartered may be void. Sponsor is not responsible if concert is delayed, postponed or cancelled for any reason; no substitution will be provided except as in Sponsor's sole discretion, and winner will not be reimbursed for tickets. Seating to be determined in the sole discretion of Sponsor. Winners and guests agree to abide by all venue rules and regulations. Failure to do may result in forfeiture of prize. Prizes are awarded "as is" with no warranty or guarantee, either express or implied. Winners are not permitted to transfer, assign or substitute a prize or redeem a prize for cash. Sponsor reserves the right to substitute a prize of comparable or greater value. Winners are responsible for all federal, state and local taxes as well as any costs and expenses associated with prize acceptance and use not specified herein as being provided. All prize details are at Sponsor's sole discretion. Limit one (1) prize per person.

PUBLICITY GRANT: Each winner, by acceptance of prize, except where legally prohibited, grants permission for Sponsor and its designees to use his/her name, address (city and state), photograph, voice and/or other likeness and prize information for advertising, trade and promotional purposes without further compensation, in all media now known or hereafter discovered, in any manner and with any materials, worldwide in perpetuity, without notice or review or approval.

GENERAL CONDITIONS: Entrants, by participating, agree that Sponsor, Harry Styles, anyone professionally associated with Harry Styles, and their respective parents, affiliates, subsidiaries and advertising and promotion agencies and all of their respective officers, directors, employees, representatives and agents (collectively, "Released Parties") will have no liability whatsoever for, and shall be held harmless by entrants against, any liability, for any injuries, losses or damages of any kind, including death, to persons, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in this Giveaway, including any travel or other activity related hereto. Released Parties are not responsible for errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Giveaway, including, without limitation, errors or difficulties which may occur in connection with the administration of the Giveaway, the processing of entries, the distribution of wristbands, the announcement of the prizes or in any Giveaway-related materials. Persons who tamper with or abuse any aspect of the Giveaway or wristbands or who are in violation of these Official Rules, as solely determined by Sponsor, will be disqualified and all associated entries will be void. Should any portion of the Giveaway be, in Sponsor's sole opinion, compromised by non-authorized human intervention or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, Sponsor reserves the right at its sole discretion to suspend, modify or terminate the Giveaway and, if terminated, at its discretion, select the potential winners from all eligible, non-suspect entries received prior to action taken or as otherwise deemed fair and appropriate by Sponsor.

DISPUTES: This Giveaway shall be governed by and interpreted under the laws of the State of New York, U.S.A. without regard to its conflicts of law provisions. Entrants hereby agree that any and all disputes, claims, causes of action, or controversies (“Claims”) arising out of or in connection with this Game or these Official Rules shall be resolved, upon the election by entrant or Sponsor, by arbitration pursuant to this provision and the code of procedures of either the Judicial Arbitration and Mediation Services, Inc. (“JAMS”) or the American Arbitration Association (“AAA”), as selected by the entrant. In addition to JAMS or AAA, Claims may be referred to any other arbitration organization that is mutually agreed upon in writing by entrant and Sponsor, or to an arbitration organization or arbitrator(s) appointed pursuant to Section 5 of the Federal Arbitration Act, 9 U.S.C. Sections 1-16, provided that any such arbitration organization and arbitrator(s) will enforce the terms of the restrictions on arbitration provision set forth below. IF ARBITRATION IS CHOSEN BY ANY PARTY WITH RESPECT TO A CLAIM, NEITHER PARTY WILL HAVE THE RIGHT TO LITIGATE THAT CLAIM IN COURT OR HAVE A JURY TRIAL ON THAT CLAIM. FURTHER, NEITHER SPONSOR NOR ENTRANT WILL HAVE THE RIGHT TO PARTICIPATE IN A REPRESENTATIVE CAPACITY ON BEHALF OF THE GENERAL PUBLIC OR OTHER PERSONS SIMILARLY SITUATED, OR AS A MEMBER OF ANY CLASS OF CLAIMANTS PERTAINING TO ANY CLAIM SUBJECT TO ARBITRATION. EXCEPT AS SET FORTH BELOW, THE ARBITRATOR’S DECISION WILL BE FINAL AND BINDING. NOTE THAT OTHER RIGHTS THAT ENTRANT WOULD HAVE IF ENTRANT WENT TO COURT ALSO MAY NOT BE AVAILABLE IN ARBITRATION. The arbitrator’s authority to resolve Claims is limited to Claims between Sponsor and entrant alone, and the arbitrator’s authority to make awards is limited to awards to Sponsor and entrant alone. Furthermore, claims brought by either party against the other may not be joined or consolidated in arbitration with Claims brought by or against any third party, unless agreed to in writing by all parties. No arbitration award or decision will have any preclusive effect as to issues or claims in any dispute with anyone who is not a named party to the arbitration. Notwithstanding any other provision in these Official Rules and without waiving either party’s right to appeal such decision, should any portion of this provision be deemed invalid or unenforceable, then the entire provision (other than this sentence) shall not apply.
